## Resolution No. 11-2022

## A RESOLUTION OF THE TEHAMA COUNTY FLOOD CONTROL AND WATER CONSERVATION DISTRICT BOARD OF DIRECTORS ADOPTING THE GROUNDWATER SUSTAINABILITY AGENCY REGULATIONS GOVERNING NEW AND REPLACEMENT WELLS

WHEREAS, pursuant to California Water Code Section 10725.2 and Water Appendix Section 82-3, the Tehama County Flood Control and Water Conservation District acting as the Tehama County Groundwater Sustainability Agency may adopt and enforce ordinances and regulations to ensure sufficient water may be available for beneficial use or uses of lands or inhabitants of both incorporated and unincorporated lands within the borders of the County of Tehama; and

**WHEREAS**, on April 18, 2022 the Tehama County Flood Control and Water Conservation District Board of Directors adopted Resolution No. 8-2022 authorizing the Groundwater Sustainability Executive to provide written verification of new and replacement well permits in response to Governor Newsom's Executive Order N-7-22; and

**WHEREAS,** on May 16, 2022 Tehama County Flood Control and Water Conservation District Board of Directors adopted Ordinance No. 2118 establishing the rules for the adoption of groundwater sustainability regulations; and

**WHEREAS**, on July 6, 2022, the Tehama County Groundwater Commission conducted a public hearing to receive and present public comments received by the Groundwater Sustainability Executive on the proposed Groundwater Sustainability Agency Regulations; and

**WHEREAS,** on September 12, 2022, the Tehama County Flood Control and Water Conservation District Board of Directors conducted a public hearing to receive and present public comments received by the Groundwater Sustainability Executive on the proposed Groundwater Sustainability Agency regulations; and

**WHEREAS,** Resolution 8-2022 shall expire upon the adoption of a permanent regulation by the Tehama County Groundwater Sustainability Agency.

**NOW, THEREFORE BE IT RESOLVED,** that the Tehama County Flood Control and Water Conservation District Board of Directors hereby adopts the Groundwater Sustainability Agency Regulations Governing New and Replacement Wells.
