AB3030 TAC MEETING OF
SEPTEMBER 15, 2008
MINUTES**

Present: Bob Steinacher; Allan Fulton; Walt Mansell and Jeff Wharton. Absent: Bill Richardson; Roger Sherrill; Colin Klinesteker; Steve Kimbrough.

1. Call to Order: The meeting was called to order by Chairman Allan Fulton, but there was no quorum. No actions were taken and brief discussions on the informational items took place.

Walt Mansell attended a Fish & Game/Department of Wildlife meeting in Tahoe, which included water use and growing population discussions.

Ernie Ohlin reminded the members of the Flood meeting for September which will include Thad Bettner, General Manager for the GCID, who will review the Stony Creek Fan Conjunctive Water Management Program.

Allan Fulton was contacted by a Capay landowner/farmer working for Caltrans. He provided a list of landowners that would like to meet with the TAC to discuss installing a dedication well in the area. Dates will be discussed for those members that would like to attend.

5. Quarterly Newsletter: Drafts were distributed for review and comment.

- Title:".*Groundwater*", that is.
- 2nd paragraph 3rd line: Groundwater is to a certain extent a "*renewable*" resource and "*is*" a very (instead of finite) OR CHANGE the concept.
- Don't include names in 4th paragraph.
- 'Finite' questioning word. Word differently. Possibly: "Groundwater is a

renewable resource however,OR Rate of renewal is highly variable from season to season and year to year. OR Groundwater is to a certain extent a renewable resource. Need to change concept.
